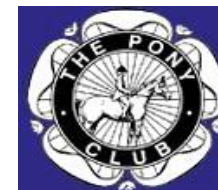


Important information for all riders

- This event is being run under Pony Club Rules 2013. Rules may be downloaded from www.pcuk.org, or are available from Pony Club HQ.
- All riders must wear a Skull Cap (not fixed peaks) with a removable cover which meets PC requirements (PAS015:1998; EN1384:1996; with BSI kite mark or Snell E2001 with official Snell label & number or AS/NZS 3838 1998; AS/NZS 3838 2004).
- All Hats must be tagged with a Pony Club Tag. We will be tagging hats on the day - but please allow time in your schedule to fit this in.
- Medical Armbands must be worn by all riders. A limited number will be on sale on the day.
- Body Protectors - an effective Body Protector must be worn. Riders who choose to use the Woof Wear Exo body cage must lodge a key with the event organiser when they collect their number.
- If a rider chooses to wear an Air Jacket, it must only be used in addition to a normal body protector and in the event of a fall, it must be fully deflated or removed before continuing. Air Jackets must not be worn under any item of clothing, and number bibs should be fitted loosely or with elasticated fastenings over the Air Jacket.
- THIS EVENT IS OPEN TO NON PONY CLUB MEMBERS WHO MUST HAVE ADEQUATE INSURANCE

WE ARE ABLE TO HOLD THIS EVENT DUE TO THE GENEROSITY OF THE LANDOWNER AND TENANT FARMERS AND WISH TO CAUSE THEM AND THE ESTATE RESIDENTS AS LITTLE DISRUPTION AS POSSIBLE

- Driving of motorised vehicles by underage persons is prohibited on the estate
- Please remove all your litter and horse muck – this is grazing land
- Please do not try to enter or leave the estate from the A620 through Scofton village
- Directions – Northbound Access from A1 – After passing over the A620 (Worksop/Retford) prepare to turn left approx. ½ mile to a small turning (not a public road) directly onto the estate. Pass over the cattle grid and straight on following the PC signs.
- Southbound – from A1 take sliproad onto A620, passing under the A1. Immediately turn right onto the Northbound A1 and follow above instructions.
- No signs are allowed on the A1 so please follow the above directions

RULES AND CONDITIONS OF ENTRY

- > No entries will be refunded except on the production of a Vet or Doctor's certificate.
- > Dogs are allowed but must be on a leash at all times.
- > Horses and Ponies must be 5 yrs. old or over. No horse or pony may compete in more than 2 classes including the PC Tetrathlon (A separate competition) which is being held on the same day.
- > Correct Cross Country dress to be worn.
- > The organisers retain the right to limit or refuse entry.
- > Objections should be lodged within 15 minutes of results and must be made in writing with a deposit of £20, which shall be returned if the objection is sustained.
- > The organisers reserve the right to disqualify any person for misuse of whip or spurs, dangerous riding or any horse in poor or lame condition.(PC members must have spurs card signed by DC if they do not hold their full B test)

Failure to comply with safety and other rules will result in elimination.

Health & Safety

- > The organisers, or anyone acting on their behalf, have taken reasonable precautions to ensure the health and safety of everyone present. For these measures to be effective, everyone must take all reasonable precautions to avoid and prevent accidents occurring and must obey the instructions of the organiser, officials and stewards.

Legal Liability

- > Save for the death or personal injury caused by the negligence of the organisers, or anyone for whom they are in law responsible, neither the organisers of the Event, nor the Pony Club, nor any agent, employees or representative of these bodies, accepts any liability for any accident, loss, damage, injury or illness to horses, owners, riders, spectators, land, cars, their contents and accessories, or any other person or property whatsoever, whether caused by their negligence, breach of contract or in any other way whatsoever.
