GENERAL REGULATIONS

- (a) Entries must be received on the Society's form by the closing date and accompanied by the proper fees as specified in the Schedule. Nominations not accepted.
- (b) Members who have subscribed £15.00 or upwards shall be entitled to make entries at the reduced fee as shown.
- (c) All exhibits must have been the bona-fide property of the exhibitor for two calendar months previous to date of entry.
- (d) Sheep exhibitors must have MV forms available for checking as they enter the main stock entrance.
- (e) All bull exhibitors must provide two handlers to be present at all times when the bull is on the Showground.
- (f) All exhibitors should ensure they are acquainted with the Society's Rules & Regulations (see page 5).
- (g) Cattle exhibitors must bring passport documents to the Show in order to record movements.
- (h) Cattle & Sheep exhibitors must send details of all handlers and attendants on the enclosed form to the Show Office with entries.
- (i) Any exhibitor that is prevented from attending the Show due to cancellation of classes will be given a full and immediate refund.

PLEASE NOTE THE UNDERMENTIONED NUMBER OF PASSES WILL BE SENT TO EXHIBITORS. IF YOU REQUIRE ANY FURTHER PASSES FOR EXTRA ATTENDANTS, THESE MAY BE PURCHASED AT £9.00 EACH.

One additional Pass will be issued to all Bull Exhibitors

- 2 Animals = 3 Passes
- 3 Animals = 4 Passes

Sheep Exhibitors Passes:

- Single Animal = 1 Pass
- 2-6 Animals = 2 Passes
- Additional Entries of 6 or more will receive 1 additional Pass
